#### ATTENTION TO ALL PROSPECTIVE EMPLOYEES

All **KITCHEN EMPLOYEES, SERVERS, BARTENDERS, AND HOSTS** must have a <u>current and valid</u> Washington State Food Handler's Card in order to be employed.

### (BUSSERS AND DISHWASHERS DO NOT have to have a food handler's card)

If you are hired and do not currently have a Food Handler's card, you will have 14 days from your hire date to obtain one. Lack of a valid Food Handler's card could result in loss of shifts and/or termination of employment.

**It is your responsibility to obtain and maintain your Food Handler's card**. Information on Food Handler's classes and certification may be obtained from:

**MANAGERS, BARTENDERS AND ANYONE** who draws beer from a tap, mixes drinks with alcohol and is at least 21 years old should have a CLASS 12 MIXOLOGIST permit.

**SERVERS THAT ARE AT LEAST 18 YEARS OLD** may carry alcohol to a guest or open beer or wine and pour it into a guest's glass at the guest's table with a CLASS 13 SERVERS permit.

# IT IS YOUR RESPONSIBILITY TO OBTAIN AND MAINTAIN THE APPROPRIATE ALCOHOL SERVING PERMIT.
